



## PRIVACY NOTICE – MARKETING ACTIVITIES

*(Articles 13-14 GDPR – Regulation (EU) 2016/679)*

### 1. Scope of Application

This notice applies whenever STESI S.r.l. carries out marketing activities directed at customers, prospects, or professional contacts, through newsletters, commercial e-mail communications, invitations to events, webinars, trade fairs, or other promotional initiatives.

It also applies to contacts collected through online forms, business enquiries, or professional meetings.

### 3. Categories of Personal Data Processed

STESI may process the following data:

- first name and surname
- e-mail address
- telephone number
- job title / role within the company
- company or organisation of affiliation
- preferences and areas of interest
- logs relating to interaction with communications (e.g., newsletter opening, click-through)

The data may be collected through:

- contact or newsletter subscription forms
- events, webinars, trade fairs
- requests for commercial information
- existing business relationships with customers or prospects

### 4. Purposes and Legal Bases of Processing

a) Sending newsletters, commercial communications, promotions, event and webinar invitations.

Legal basis:

- the data subject's consent (Article 6(1)(a) GDPR); or
- the Controller's legitimate interest (Article 6(1)(f) GDPR), where the recipient is an existing customer and the communications relate to similar products or services (Article 130(4) of the Italian Data Protection Code).

b) Statistical analysis of interactions with communications (open rate, click-through rate).

Legal basis:

- consent, where the analysis involves profiling or individual tracking;
- legitimate interest, for non-invasive aggregate analysis.

c) Management of subscriptions, unsubscriptions, and preferences.

Legal basis:

- compliance with legal and regulatory obligations;

- the Controller's legitimate interest in the proper management of contact lists.

#### 5. Data Retention Period

Where processing is based on consent: until such consent is withdrawn, and in any event for no longer than 24 months from the last significant interaction.

Where processing is based on legitimate interest (existing customers): for up to 24 months from the last relevant contact or business relationship.

Upon expiry of these periods, the data will be deleted or anonymised.

#### 6. Disclosure of Data

The data may be disclosed to:

- providers of e-mail marketing services (e.g., Odoo, and similar);
- CRM service providers;
- companies organising events or webinars on behalf of STESI;
- authorised consultants and business partners;
- sub-processors appointed pursuant to Article 28 GDPR.

An updated list of external Data Processors is available upon request.

#### 7. Transfers Outside the European Union

Where personal data are processed through services involving transfers to countries outside the European Union, such transfers will be carried out in compliance with Articles 45-46 GDPR (adequacy decisions, Standard Contractual Clauses, and supplementary measures).

#### 8. Rights of the Data Subject

The data subject may, at any time:

- withdraw consent previously given;
- object to the processing (Article 21 GDPR);
- request access, rectification, erasure, or restriction of processing;
- request data portability, where applicable;
- lodge a complaint with the Italian Data Protection Authority (Garante per la protezione dei dati personali – [www.garanteprivacy.it](http://www.garanteprivacy.it)).
